#### STRUCTURED SPEECH

Honourable chairs, honourable delegates,

The Kingdom of Sweden is very eager to start debating and negotiating concerning the topic of Indigenous Peoples, because we believe that this specific issue deserves our attention and our action. It is at the heart of our delegation's objectives to also give people, feeling that they cannot identify with a country's dominant culture for any reason whatsoever, the same opportunities and respectful treatment as we would give any other citizen. The Kingdom of Sweden believes that, during this debate, three main steps can be taken:

- firstly, we plead for constant attention to this matter, because we believe that we can no longer ignore its existence;
- secondly, we would like to emphasise the need of better regulations in all member states regarding the rights of indigenous peoples;
- thirdly, we aim to ground an institution that will ensure the abidance to these regulations of all involved member states.

We believe that we can solve this issue efficiently and effectively, if all nations and international organisations cooperate. Thank you.

Honourable chairs, honourable delegates,

The topic of ensuring a fair treatment to Indigenous Peoples is a topic that the United States of America are very passionate about, because we see it as one of the UN's core values that we can guarantee the same treatment and rights to any citizen.
